

On 4th May 2023 at around 11:00 am unknown miscreant suspected to be Arambai Tenggot, Kangpokpi Kanka Lup (KKL) Meitei Leipen numbering about hundred and thousand dismantled and destroyed over building and properties e.g. vehicles, Amitrak, furnitures, Apple Laptop (Macbook) fridge, washing machine, Denlops and many expensive things etc. The value of the lost including all properties may lost around 75 Lakhs approximately.

So due to the violence erupted, I could not report the matter to my concerned Police Station at on time.
