The suspected miscreant belongs to Meitei organization viz, Arambai Tengol, Kangleipak Kanbe Lup, Meitei Khepui joined by local goons. The estimated value of properties damaged and looted is around 7.00.000 Rupees (7 Lakhs).

I could not report the incident on the day and to concerned PS due to unprecedented law and order situation in the State.
