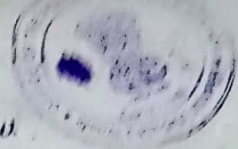

With due respect, I the undersigned would like to inform you that, on the evening of 17th May 2023, at around 6:00 pm some unknown miscreants belonging to Meitei Youth organization suspected to be members of Grambar Tengol who are loyal group to World Meitei Council (WMC) Meitei Deepun and Kanglipok Kanba Luf and Schedule Tribe Demand Committee (STDC) numbering around 1000 plus members attacked my residence as a tenant at village no. 26/A Mangpok Orghat Sak no. 4224 (Chasrad Avenue) 1/2. They looted all valuables and vandalized my rented house. The approximate value of lost and destroyed properties to be about 10 lakhs.

It is therefore requested to kindly register a regular case and take necessary legal action according to law.
