With due respect, I the undersigned would like to inform you that, on the evening of 16th May 2023, at around 6:00 PM some unknown miscreants belonging to Meitei Youth organization suspected to be members of Thambas Tengot who are loyal group to local Meitei Council (LWC) Meitei Leipun and Kangnipetli Vanbo Lup and Schedule Tribe demand Committee (STD) numbering around 1000 plus members, attacked my residence as a tenant at Village no. 26/A Sonopara Orkheti Dok no. 4224 (Chassad Avenue) 1/2. They looted all valuables and vandalized my rented house. The approximate value of lost and destroyed properties to be about 10 lakhs.

It is therefore requested to kindly register a regular case and take necessary legal action according to law.
