Subject: Complaint regarding destruction of believers Eastern Church building, personage and properties of the church at Torongthel, PO- Yairipok, PS- Andro, Imphal east District, Manipur-795149 on may 6,2023 on 11:30 am.

Respected Sir,

As you aware, a communal pogrom swept our state between may 3 to 7, 2023 leading to a grave loss of life and widespread destruction of personal and public property. Entire villages including homes and places of worship were burnt and razed to the ground. Thousands of persons were force to flee their homes and villages and are now displaced.

Amidst this violence and arson that spread through Manipur, on May 6 023, on 11:30 am, a group of approximately 1000 people came to the church premises and attacked and destroyed our church building and asset and properties of the church located in Torongthel, PO – Yairipok, PS- Andro, Imphal East District -795149. Te mob was armed with spades, axes, Sticks, and other deadly weapons and they broke down the door of the Church, defiling the sanctity of the place of worship and completely demolished the Church building, hope for children Tution centre building and properties causing damage worth Rs. 35,50,000/-(Thirty Five Lakhs and Fifty Thousand) Only. During the attack, the mob also verbally abused the Christians and threatening them to abandon their faith and return to their original religion.

This is a detail description of monetary loss that we suffered:

Apart from this loss that we have already suffered due to the absolute breakdown of law and order in our state, we are now also being threatened to renounce Christian faith and accept the indigenous faith and threat to encroach our church property.

We request your goodself to intervene in this matter urgently and protect our land and property and our life and limb from any further loss or damage. Your are also requested to register an FIR and submit the computation of the loss to our property mentioned here, to any appropriate body of the state government to grant us the compensation that we need to rebuild our lives.
