With due respect, I have the honour to report that today i.e. 20/11/2023 at around 12:04 pm while I was attending one Jeiga function at the residence Maibam Robert Singh located at Irilbung bazaar, one of my salesman namely Tubur Sampar informed me that some unknown armed youths numbering about 5/6 came at my M/S E.I. & Son (J.K.) Iron & cement store located at Irilbung Bazar and forcibly broke the locker of store. They looted away a sum of Rs. 2.5 to 3 lakhs which was kept inside my locker by threatening the life of my salesman. The armed youths immediately went away towards Andro side in a Hyundai Venue car white in colour without registration number.

It is therefore requested you kindly to arrest them and punished as per section of law at the earliest.


