Subject: Report.

Sir,

I have the honour to report that today, i.e., 24/11/2023 at around 9:20 pm, Md. Rakib aged about 25 years S/o Md. Ibocha of Keirao Makting Litan Makhong trespassed the Grocery Shop of Mrs. Najira located at Keirao Makting Litan Makhong and broke open the locker of the Grocery shop and robbed a sum of Rs 45,000. Later, he again broke one door between the Grocery shop and my carpentry workshop which is adjacent to the Grocery shop. On noticing the presence of my carpentries namely Ojit (35 yrs) and Sanathoi (27 yrs) who were having dinner inside their room, he stabbed both Ojit and Sanathoi with a chisel multiple times to kill them on the spot so as to concealed his crime and escape from the scene of crime. As a result of which both Ojit and Sanathoi got serious injuries on their persons and evacuated to JNIMS, Hospital Porompat for medical treatment.

It is therefore requested to arrest the accused for inhuman act and punished him accordingly as per law.
