

Today i.e. 28/11/2023 at about 11.21 p.m. received an information that at about 9.33 p.m., of 28/11/2023, unknown armed miscreants numbering about 15(fifteen) persons broke opened the gate of one Thokchom Ingoba Singh (58), s/o (L) Th. aigoi of Uchekon Chongabi and abducted the said Ingoba under threat and duress. He was abducted in a Bolero olive green colour without registration number and escorted by 4(four) white Gypsy, one Baleno red in colour and took away towards Khongman Ator Leirak. Ingobi held a mobile phone bearing 8974058491. He works at MSRRDA as Additional Chief Engineer. The unknown armed persons claim that they were UNLF.

Hence, a case under FIR No. 65(11)2023 IBG-PS U/S 365/427/452/34 IPC, 20 UA(P) Act. & 25(1-C) A. Act is registered Suo-motto.
