With reference to the above subject, it is to bring to your kind notice that the EPC contractor has setup its camp for the construction of NH-102B under Bharat Mala (NHIDCL - 4B) at location Chainage km.125+380 in Khuanggin/Sinzawl village at Pherzawl District for improvement of Churachandpur to Tuivai NH road. As you are aware, the said camp has been attacked and vandalized in the late evening of 05/05/2023 by unknown miscreants resulting in destroying and burning of camp including heavy machinery/tyres/diesel/fuel and lubricants/ plywood cement bags/rations, etc.

In the midst of unrest situation in the State of Manipur, it has been informed to us that the left out heavy machineries, trucks, etc have been again further damaged and stolen day by day by the local villagers of the above mentioned villages. The relevant damaged photographs and list of the machineries are enclosed.

Such attacked and damaged report had already been informed to DGP, Chief Secretary, Security advisor, etc of Government of Manipur from time to time. In this regard, it is further to inform you that Shri. Dr. I.K Muivah, IGP (OPS) for DGP, Manipur has given necessary instruction to their subordinate SP, ADG, etc for providing necessary security.

In view of the above formidable situation, you are requested to take necessary action by lodging FIR against those anti-social elements of Khuanggin & Sinzawl villagers involved in the unlawful activities.
