1. That I am a Special Contractor by profession of the Government of Manipur being Regd No. 34/7/201 11-W and carrying out the work of PMGSY " NH-150 Thanlon to Mongon under Churachandpur Block under Packaged No. MN 0-3237" working under the Agency named Chirom Iboyaima Singh, Special Class Contractor (PMGSY)
2. That I had contracted a shed near 1st River bank about 5km from Thanlon bazaar for carrying out the said contract work and parked my said vehicle (Tandem Roller CC 125) and utilized the said shed as a godown and due to the present situation all Meitei workers/labourers had fled from the said site and asked the local people to take care of the said site and other goods and my said vehicle.
3. That my vehicle i.e Tandem Roller CC125 was intact till 8th October, 2023 however on 9th October, 2023 I was informed by some local person whom I had engaged to look after my work site that my said vehicle was not there at the work site.
4. That since the said vehicle was not found in spite of my concerted effort I am giving the present report for the loss of the said vehicle according to law and to recover the same at the earliest.
