It is to inform you that on the 4th of May, 2023 at around 7:00 PM, a group of Meitei organization numbering more than one thousand attacked my private house at Phainom Veng, National Games Village, Imphal West and burnt down and vandalized my house including all my properties and my one building house on the homestead land PATA No. 2937/3479, DAK No. 837/839 Area of 0.0283 acres recorded in my name Laltingen Vaiphei and 01 Maruti 800 car bearing Registration number MN06L1352 and 02 numbers of two wheeler Activa scooters bearing Registration numbers MN06SG9088 and MN01U7384.

The approximate worth of properties vandalized is above 1.5 Crore only.

It is therefore requested to lodge FIR in connection with this incident and take up necessary action at the earliest.
