Subject : Complaint Report (FIR)

Sir,

I beg to state that, on 3rd May 2023, at around 6:00 pm, our locality National Games Village, Imphal West under Lamphel Police Station, P.O. Lamphel (Imphal West and falling under revenue of Imphal West) was attacked by thousands of violent mobs belonging to the Meitei Community with an intent to murder the Kukis residing in the area.

As a result of which, many houses and properties were destroyed and burnt to the ground. My permanent house was also destroyed by the mobs and all my properties including the house were burnt continuously from date 3rd of May by different mobs while the lifelines were looted and vandalised.

Properties looted, burnt and destroyed include the following:

1. Immovable properties : Patta No. $\frac{191}{\text{Old}} / \frac{526}{3188} \text{ (New)}$
2. Movable properties :

a) Gold & Jewellerys - Approx. 2.5 lakhs

- Granaries & Foodgrains - Rs 10,000/- (Around 5 bags of Rice)
- i) Important documents - class 8, XII Admit cards & related certificates (Burnt)
- d) Vehicles - 4 wheellers (Alto car damaged), others - Rs 15,000 approx
- e) Furnitures - 9 lakhs approx.
- f) Traditional heritage :
- Ornaments - 60,000

 - Shawls - 20,000
 - Gongs - 60,000
 - Lunge - 30,000
 - Others - 25,000 approx.
- g) clothing items - 5 lakhs approx

 - Desktop - 30,000
 - Refrigerator - 50,000
 - Washing Machine - 25,000
 - Printer - 7,000
 - Cameras - 45,000
 - TV Set - 60,000
- i) Kitchen items (Everyday used & unused items) - 3 lakhs approx.
- j) Guitar - Rs 18,000/-
- k) Syntex - 7 pieces 1000 litres - Rs 35,000/-
- l) Licensed Guns (S&W Single Barrel with ammunition) - Rs 43,000/-
- m) Cash (looted by miscreants) - Rs 6 lakhs approx.

I, therefore request you to kindly take necessary legal action to arrest the culprits involved in the incident at the earliest in the interest of justice. I hereby lodge my complaint at your Station as I had fled from my residence to save myself and my families from the rioters.
