It is to inform you that on 4<sup>th</sup> May, 2023 at around 6:00 pm a group of Meitei Organisation numbering more than 1000 (one thousand) suspected to be Arambai Tenggol, Kangleipak Kanba Lup, Meitei Leepun attacked my Quarter at National Games Village and vandalised my properties and looted all my household properties in which a sum of Rs. 7,00,000/- (seven lakhs) only which I have taken Personal Loan from Punjab National Bank was also looted. They also burnt down my private vehicle Honda Activa (no Regn. Number) which I have taken on loan recently from Punya Showroom Sangakpham.

The approximate total cost of items worth is Rs. 30,00000/- (thirty lakhs) only.

It is therefore requested to lodge FIR in connection with this incident.
