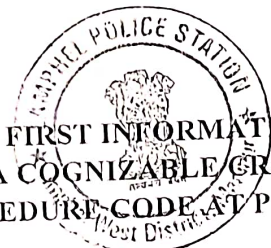

In the process, they looted all our house
hold properties and later vandalised
the house including all our documents
and certificates.

The total cost of our properties they
damage and destroyed are estimated to
be more than 10 Lakhs only.

I therefore requested you to
kindly take up necessary action as per
Law of the land.
