Sir,

I have the honour to state that, on 4th May, 2023 at around 8:00 PM some unknown miscreants belonging to Meitei Youths Organization suspected to be members of Meitei extremist Arambai Tenggol who are loyal group to the present Inner MP, Shri Leishemba Sanajaoba, World Meitei Council (WMC), Meitei Leepul and Kangleipak Kanba Lup (KKL) and Scheduled Tribe Demand Committee (STDC), Manipur Police and Commandos who take direct command from the CM N. Biren Singh, numbering about 1000 members carrying sophisticated weapons like AK rifles, 303 Rifles, SBBL, Pistol, Molotov, etc. with vehicles forcefully entered in my village located at **Langol Housing Complex**. They looted all valuables and vandalized my house, moveable properties and leaving us homeless.

The approximate value of lost and destroyed properties are to be about **50 Lakhs**.

I, therefore, request to kindly register a regular case and take necessary legal action according to law.
