Sir,

This is to report that on the 4th May 2023 at around 8:30 p.m, a belligerent mob of Meitei Community numbering around 2500 (two thousand five hundred) stormed my house at Langol Housing Complex, Type-II (A), Qrt. No. 38 Imphal West District, Manipur and engaged in indiscriminate arson, looting theft.

In the incident, all properties at my resident house is destroyed, burned and looted.

Details of properties looted are as listed below :-

2. Alto 800 bearing registration No. WB16AE-0863 worth Rs.2,20,000/-
3. T.V. 43 inch worth Rs. 50,000/-(fifty thousand)
4. Washing Machine Plus + 10 Kg. worth Rs. 30,000/-
5. 2(two) Nos. of steel Almirah and 2(two) Nos. wooden almirah of worth Rs. 1,20,000/-
6. 4(Four) Nos. of Wooden Bed Box and with King-size mattress and blanket worth Rs. 1,10,000/-
7. Traditional shawl and clothes worth Rs. 1,50,000/-
8. 1(One) no. of Gas Stove and 3(three) Nos. of Gas Cylinder worth Rs. 30,000/-
9. Cash Rs. 1,50,000/-
10. Utensils worth Rs. 90,000/-
11. 3(three) Nos. of Sintex -- 500 litres capacity worth Rs. 7000/-
12. Water motor(Tullu) worth Rs. 3,000/-
13. Computer set worth Rs. 45,000/-
14. Furniture (Table, Chair, Sofa) worth Rs. 1,10,000/-
15. Inverter -- 5,500/-
16. Variety store + Dukan Worth Rs. 1,50,000/-

The total value of properties lost at my rented resident is about 13,90,500/- (Thirteen lakhs Ninety thousand five hundred) only.

I, therefore, fervently request you to take further necessary action at the earliest as per law of the land.
