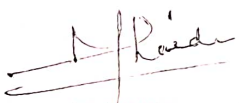

Sir,
I would like to draw your kind attention towards
the unfortunate incident that occurred at my residence
on the fateful day of 4th May, 2023^{PM} where
my house was destroyed, ransacked and looted
by migrants. I would like to list down the
property items which was looted:-

- 1) Suitcase cost ₹ 15,000/-
 - 2) Furniture: 4 almira, Common room walls, Kitchen
walls, doors, dining table set with 6 chairs (₹ 90,000/-)
 - 3) Washing machine, refrigerator, water pump, syntax
television, fan 2, sofa set, cushions, side tables
approx. 2 lakhs.
 - 4) Blanket 8 (₹ 30,000/-)
 - 5) Kitchen items: 4 gas cylinder, 1 gas stove, kitchen
utensils approx. ₹ 70,000/-
 - 6) 1 laptop, 1 tablet approx. ₹ 80,000/-
 - 7) 1 mattress ₹ 20,000/-
 - 8) Pure gold 1 gram worth approx. ₹ 15,000/-
All but from the quarter (Approx. 8 lakhs)
- Total estimate = 8 lakhs

Therefore, I would be grateful if you could kindly take up the matter and do the needful at the earliest.
