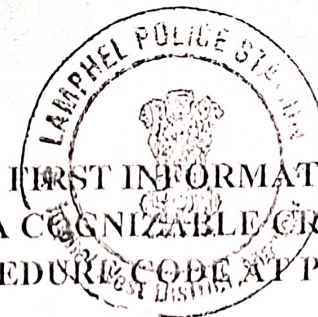

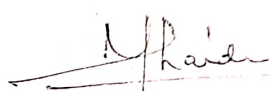

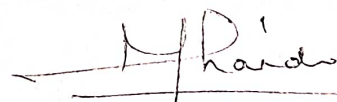

Subject : Complaint report

Sir,

I am to state that, on 4th May 2023, at about 3p.
our locality Khongsai Veng, Laiphom Khuron, under Lamphei
Police Station (Imphal West and falling under revenue of
Imphal East) was under mob attacked by thousands of
unknown miscreants belonging to the Meitei community who
are intend to murder.

As a result, many houses and properties were
crosses were destroyed and burnt to ashes. My house
no. 49 (Rent / Permanent residence) was also destroyed &
the mob, many properties were burnt and leftover looted.

Properties looted, burnt and destroyed included :
1) Immovable properties like House having - 2 storied building

2) Movable properties

(a) Gold and Jewellery : 20 Karat Gold Chain (720 g),
5 ear-rings, 3 necklaces, 4 rings.

(b) Granary and Grain : 100 bags of rice

(c) Documents : Land ownership certificates, employee certificates,
identification certificates, and many other
important certificates.

(d) Vehicles :

(e) Furniture : 2 sofa sets, 5 wooden beds, 2 bed boxes, dining table
and chairs, 2 dressing tables, 5 wooden almirahs,

1 steel almirah, TV table, computer desk, study tables and chairs,

(P) Traditional ornaments: 2 gongs, 5 Khiba, 5 hat and 5 Khichang

(Q) Modern and traditional garments: Traditional shawls, wrap-rounds, vest, neck tie worth more than 1,00,000/-

(R) Gas Book: 2 Misao gas book, 2 gas stoves, 5 cylinders.

(S) Electronic items: Washing machine, geysers, solar water heater, R.O. water purifier, laptops, microwave oven, desktop TV, fridge, electric drum and guitars, speakers, amplifier, toaster, electric cooker, water boiler, room heaters, exercise machine.

(T) Cash: 3,20,000/-

(U) Clothing and dresses worth more than 7,00,000/-

(V) Syntex - 5 (1000 l)

Total loss of properties at my residence would be above Rs 7,00,00,000/-

It is therefore kindly requested to take necessary legal actions to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complain at Kangpokpi Police Station as I had fled from my residence to save myself and my families from the rioters.
