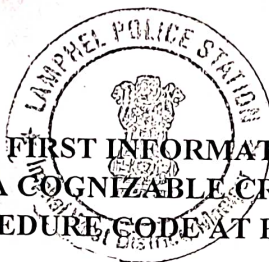

Sir,

I am to state that, on 4th May 2023, at about 3 p.m.
our locality Khongsa Veng, Lampham Khunou, under Lamphel
Police Station (Imphal West and falling under revenue of
Imphal East) was under mob attacked by thousands of
unknown miscreants belonging to the Meitei community with
an intent to murder.

As a result, many houses and properties worth
crores were destroyed and burnt to ashes. My house
no. 61 (Rent / Permanent residence) was also destroyed by
the mob, many properties were burnt and leftover looted.

Properties looted, burnt and destroyed included:

1) Immovable properties like House having -

2) Movable properties

(a) Gold and Jewelry: 22 Karat Gold chain (700g),
2 ear rings, 2 necklaces, 2 rings.

(b) Granary and grain: 20 bags of rice, each weighing 50kg

(c) Documents: Employee certificates, land ownership certificates,
identification certificates, and many other
important certificates.

(d) Vehicles: Renault Kiger RXT (MN01AW 3228)

(e) Furniture: 3 wooden beds, 2 wooden almirah, 1 steel almirah,
1 sofa set, 1 tv table, 2 dressing tables, dining
table and chairs,

(f) Traditional ornament: 2 gongs, 3 Khiba and Khichong

9. Modern and traditional garments : 1 almirah full of traditional shawls and wrap-rounds, neck tie and vest.

h. Gas Book: Misao gas book, 1 gas stove, 3 cylinders.

i. Electronic items: TV, fridge, solar water heater, Microwave Oven, Washing machine, laptops, Desktop, electric cooker, treadmill, speaker, electric guitar, geysers,

j. Cash : 1,50,000/-

k. Bicycles (3), Syntex - (1000 l (4), 500 l - (2))

l. Clothing and dresses worth more than 3,00,000/-

Total loss of properties at my residence would be above Rs, 5,00,00,000/-

It is therefore kindly requested to take necessary legal actions to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complain at Kangpokpi Police Station as I had fled from my residence to save myself and my families from the rioters.
