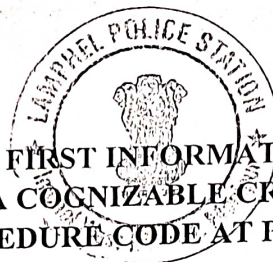





Subject : Lodging FIR.

Sir,

This is to inform that on the 4th May 2023, a belligerent mob of Meitei Community numbering around 3000 (three thousand) stormed my rented house at Langol Housing Complex Quarter Number A/II/47, PO/PS Lamphel, Imphal West District, Manipur and engaged in indiscriminate arson, looting theft.

In the incident, all properties at my rented resident house is destroyed, burned and looted.

Details of Properties looted are as listed below :-

1. T.V. 65 inch worth Rs. 52,000/- (Fifty Two Thousand)
2. Washing Machine 11 Kg Whirlpool Company worth Rs. 22,000/-
3. Refrigerator worth Rs. 23,000/-
4. 3 (Three) nos. of steel Almirah worth Rs. 60,000/-
5. 2 (Two) Nos. of wooden Bed Box with king-size mattress and blanket worth Rs. 1,00,000/-
6. Traditional shawl and clothes worth Rs. 90,000/-
7. 2 (two) no. of Gas Stove and 4 (four) Nos. of Gas Cylinder worth Rs 32,000/-
8. Cash Rs 2,00,000/-
9. Utensils worth Rs 50,000/-
10. 2 (Two) Nos. of Sintex – 1000 litres capacity worth Rs 9,000/-
11. 4 (Two) Nos. of Sintex – 500 litres capacity worth Rs 9,200/-
12. Generator and Water Motor (Tullu) worth Rs 45,000/-
13. Computer Set worth Rs 9,000/-
14. Furniture (Table, Chair, Sofa) worth Rs 80,000/-
15. Gold Ring and Necklace worth around 2,00,000/-

The total value of properties lost at my rented resident is about 9,81,200 (9 Lakhs 81 Thousand and Two Hundred) only.

I, therefore, urge you to take further necessary action at the earliest as per law of the land.
