



It is to inform you that, on the 4th May 2023, at around 09:30 am, unknown miscreants attacked my Quarter No. B/46 Type-2 Langgol Housing Complex, Imphal West. The unknown miscreants numbering about one thousand people suspected to be the members of Arambai Tengol, Kangleipak Kanba Lup, Meetei Leepun and Meitei ST Demand Committee pelted stones and damaged all the house windows. Afterwards they forcefully entered our house and looted all our properties.

The list of properties looted are mentioned below.

- I. Activa 6G worth ₹. 1,10,000
- II. Furniture: Sofa Set (2-No.) ₹. 70,000/- One Kingsize Bed ₹. 45,000 One Dressing Table ₹. 24,000/- Shoe Rack ₹. 2000/- Utensils Rack ₹. 15,000/- One Double Bed ₹. 9000/-
- III. Sintex (3 No.) ₹. 9000/-, Blankets (10 No.) ₹. 20,000/-, Clothing Items ₹. 2,50,000/-
- IV. Electric Cooker ₹. 4000/-, Dinner Sets, Cutleries, Plates ₹. 8000/-

Total Estimate ₹. 6,00,000/-

You are therefore requested to lodge zero FIR so that proper investigation could be done on time.
