



Subject: FIR on destruction of National Games Village, House No. A-85, Zone-III, Imphal West on 4th May, 2023.

Sir,

I am to state that, on 4th May, 2023, at about 3:00 PM, our locality National Games Village, under Lamphel Police Station (Imphal West) was under mob attacked by thousands of a Meiteei Organisation i.e. **Arambai Tenggol, Kangleipak Kanba Lup** with an intend to murder.


As a result, many houses and properties worth crores were destroyed and burnt to ashes. My house **No. A-85 (Zone-III)** (Permanent Residence) was also destroyed by the mob along with 3 (Three Two Wheeler) bearing Registration No. Destine: **MN06SC4935**, Activa: **MN019509**, Maestro: **MN06SC4334**, many properties were burnt and leftovers were looted.

Total loss of estimated properties burnt and looted would be above **Rs. 65, 00,000/- (Sixty Five Lakhs)**


It is therefore kindly requested to take necessary legal action to arrest the culprit involved in the incident at the earliest in the interest of justice. I hereby lodged my complaint at Kangpokpi Police Station as I had fled from my residence to safe myself and my families from the rioters.
