That, we are a family of 6 members staying at Leimatak Silen Bazar, and a residential grocery shop was run by my mother in law Yumnam Jamuna Devi (59), however due to the current communal clash we left Leimatak leaving behind all our belongings.

However, today i.e. 19/08/2023, we received an information from one of our friends at Leimatak that our house has been broke in and all our household items as well as the items from my mother in law's shop has been completely stolen by unknown Kuki miscreants. The approximate value of the stolen items is around 30,00000 (Thirty lakhs)

Hence, I sincerely request you to kindly take up necessary action.
