

Respected Sir,

I would like to state the following few lines for your kind attention and necessary action.

That, I am a contract employee of NHPC Loktak posted at Power House Station, NHPC Leimatak. I have quarter no Zero C-29 allotted by NHPC Leimatak. Due to the communal violence, on 7/05/2023, I left my quarter for my safety and leaving behind all my belongings including a 2 wheeler Honda Activa Gray in colour bearing reg. no MN06SE7869 with chassis no. ME4JF914MG624137 and Engine no. JF91EG1623289 which is locked & kept inside the above mention quarter.

However on 01/09/2023 at around 4:00 PM I received an information from one of my friend at Leimatak stating that my quarter has been broken in and all my household items were being damaged & stolen as well as my two wheeler vehicle has been also stolen by some unknown suspected to Kuki miscreants or militants. The approximate value of the stolen items is around Rs. 3,20000 (Three Lacs & Twenty Thousand only) including that of the cost of the vehicle.

Hence, I sincerely request you to kindly take up necessary legal action.
