Requested Madam,

With reference to the above cited subject, I have the honour to report to your good office as follows:

That I, Helhing Kuki age about 60 years W/O (L) Lamthang Kuki belonging to the any Kuki tribe/community, a Schedule Tribe recognized under the constitution of India, by virtue of which I am being entitled to the protection under the SC/ST (Prevention of Atrocities) Act, 1989.

That, I would like to inform and register a cognizable office carried against me and my family at our quarter located at Zero Colony, Quarter No. 44, Type-II, NHPC, Loktak Project, Bishnupur District. PS Loktak Project.

That, on the 8<sup>th</sup> of May, 2023 at around 6:00 PM, a huge contingent of armed radical Meetei/Meitei suspected to be members of the Arambai Tengol and Meetei/Meitei Leepun attacked our deserted locality and in the process vandalized and looted down our house along with all the properties.

That, it may be reported here that above said criminal activities have caused grave mental agony and incurred huge loss which may be estimated (approx.) to be Rs. 10,00,000/-(Ten Lakh) only.

Fortunately, me and my family managed to escaped from these criminals who even tried to kill and now currently taking refuge at leimata Power House, PO & PS Churachandpur district, Manipur.

I am filing this report lately since I have been at different places for safety. Now, since I am able to settle myself at the above mention address, I am in a position to file a report today. Hence, prayed that my report be accepted.

In the given circumstances, I humbly pray you to kindly register a zero FIR, investigate the matter and punish the perpetrators as per the prevailing provisions of the laws of the land. And, for which act of kindness, I shall always remain thankful to you and obliged.
