





Sir,

As per your endorsement under GD number 15/TBL-PS/2023 dated 24/10/2023, I have conducted field enquiry regarding the complaint report filed by Kharibam Premkumar Singh (50) yrs S/o Kh. Lakho Singh of Charangpat Maning Leikai, Secretary, Defence Union Club, Charangpat Maning Leikai, thoubal District. That, the people of Charangpat Maning Leikai depend upon the Arong river as a vital source of water, but due to recent dumping of dead pigs by unknown miscreants into this river and floating down through residential areas endangers public health and hygiene. Accordingly, I have visited at Charangpat Village near Maning Leikai and inspected the Arong river, during enquiry the dead pig were found to have been buried in safe places by the local people.

Such act committed by the unknown miscreants amounts to spread infection of diseases dangerous to human life thereby causing health hazard.

It is therefore submitted, this report, for taking further necessary legal actions against the unknown miscreants and for not to commit such harmful act in future.
