I have quarter No. Type-III/C-6 allotted by NHPC Leimatak. Due to the communal violence of 03/05/2023, on 07/05/2023, I left my quarter for my safety and leaving behind all my belongings including:-

1) House hold Electronic items:-T,V, Flat, Refrigerator, Washing Machine, EVD Machine, Center Box TATA Sky, Wall Clock, Radio Set, BO Apparatus, Stabilizer, Stethoscope and Grinder

2) Jewellery Items:-

2(two) Gold Chain for man & woman and Rs 56000/-(Rupees fiftysix thousand) of Money

3) Sports Items:- 2(two) Racket, 2(two) pairs Sport Shoes, 12 pieces of Shuttle, 1(one) Baby Cycle, 6(six) pairs of Baby shoes, 3(three) pairs of Man shoes, 5(five) pairs of Woman shoes.

4) Furniture Items:-

Double Bed, Single Bed, Sofa Set, 6 pieces of Plastic Chair, Dining Set, Dressing Table Set

- 5) Kitchen Utensils Items:2 pieces of Gas Cylinder, Gas Stove/Frame, 3 pieces of Pressure cooker, 2 pieces of rice cooker, Gas Box
- 6) Food Items:100 Rice of Meitei, 5 bags of Supper fine Rice and Grain:
