

Sir,

I, along with my family have been staying at Leimatak Silen Bazar for the past 30 years. Due to the current communal clash, on 25/05/2023, I along with my family members left our house for safety and fear of our lives thus leaving behind all our valuable household articles, kitchen items, apparels, commercial items, cows, pigs etc. amounting to altogether Rs. 13,96,800/-(Rupees thirteen Lakhs and Ninety-Six Thousands and Eight Hundred).

Recently, on 17/09/2023 5:30 PM I received an information from one of my friends at Leimatak informing that our house has been looted and destroyed by unknown persons suspected to be of Kuki miscreants/militants.

I could not report in timely to the concerned police station due to the prevailing situation of Manipur and I myself with my family members were displaced and stranded, taking shelter at the Relief Camp, Mangolnganbi College, Ningthoukhong, Manipur.

Hence, I request you to kindly take up necessary legal action.


