Sir,

I am a contract employee of NHPC posted at Leimatak and have been staying at Leimatak since 1992. Due to the current communal clash, on 07/05/2023 I along with my family members left my Quarter Type-III leaving behind all my valuable household items, kitchen items, apparels, commercial items, gold ornaments, cash amounting to altogether around Rs. 24,22,000/-(Rupees Twentyfour Lakhs and Twenty-Two Thousands).

On 14/09/2023, at around 3 PM, I got an information from someone at Leimatak stating that my quarter was broke in and all the household items and everything we left has been stolen by unknown persons suspected to be of kuki miscreants/militants.

I could not report in timely to the concerned police station due to the prevailing situation of Manipur and I myself with my family members were displaced and stranded, taking shelter at the Relief Camp, Mangolnganbi College, Ningthoukhong, Manipur.

Hence, I request you to kindly take necessary legal action.
