

My husband Pangambam Romesh Singh is a contract worker at NHPC Leimatak. We were allotted quarter type 2 house no.26. Due to the current communal clash, on 07/05/2023, I along with my family members left our house for safety and fear of our lives thus leaving behind all our valuable household articles, kitchen items, apparels, commercial items, gold ornaments amounting to altogether around Rs. 18,41,500/- (Rupees Eighteen Lakhs and Forty-onethousand and five hundred)

Recently, on 10/09/2023 1:30 PM I received an information from one of my friends at Leimatak informing that our quarter has been looted and destroyed by unknown persons suspected to be of Kuki miscreants/militants.

I could not report in timely to the concerned police station due to the prevailing situation of Manipur and I myself with my family members were displaced and stranded, taking shelter at the Relief Camp, Mangolanganbi College, Ningthoukhong, Manipur.

Hence, I request you to kindly take up necessary legal action.
