

Sir,

I have been staying at Jeevan Nagar Kukimum Village for the 35 years along with my family. Due to the current communal clash, on 17/09/2023 I along with my family members left our house for safety and fear of our lives thus leaving behind all our valuable household articles, kitchen items, apparels, commercial items, gold, cash amounting to altogether around Rs. 11,97000/-(Rupees Eleven Lakhs and Ninety seven thousand and five hundred) .

Recently, on 14/09/2023 11:30 AM I received an information from one of my friends at Leimatak informing that our quarter has been looted and destroyed by unknown persons suspected to be of Kuki miscreants/militants.

I could not report in timely to the concerned police station due to the prevailing situation of Manipur and I along with my family members were displaced and stranded, taking shelter at the Relief Camp, Mangolnganbi College, Ningthoukhong, Manipur.

Hence, I request you to kindly take up necessary legal action.
