

Sir,

With reference to the above cited subject I have the honour to report to you as follows:

1. That I T. Lettinmang Haokip aged about 42 years S/O (L) H.T Doukholum belonging to the any Kuki Tribe/ community, a schedule Tribe recognized under the constitution of India, by virtue of which I am being entitle to the protection under the SC/ST (Prevention of Atrocities) Act, 1989 and that I am a resident of Loktak Project Zero colony Quarter Loktak Project Churachandpur district Manipur, PO & PS Loktak.
2. That at about 12:30 PM on the 4th May 2023, due to the ethnic tension in the state of Manipur me and my family run for our lives leaving behind all our household items and in the process some unknown miscreant have looted our quarter including all our household items.
3. That, it may be reported here that the above said criminal activities have grave mental agony and incurred huge loss which may be estimated to be Rs. 10,00,000/- (Rupees Ten Lakhs) only.
4. Fortunately, I managed to escape from the place and now currently taking refuge at M. Songgel Village Churachandpur.
5. That I am filing this information lately because there is a great danger to my life and due to which I was at different places to save my life and now I am able to restore my health and settled at the above mentioned place. And thus I am filling the report lately today.


