

I would like to state the following few lines for your kind attention and necessary action.

That, I am a contract worker with NHPC Loktak posted at Leimatak. My allotted quarter no. is type 3/C-11. However due to the current communal clash, I had to leave Leimatak on the morning of 07/05/2023 for my safety.

On 20/09/2023, around 2:00 PM I received information from one of my friends at Leimatak informing that all my household items as well as a 4 wheeler vehicle Maruti Omni E bearing reg.no.MN 06LA-9041, engine no. F8BIN4684002 and chasis no. MA3EVB11S01494620 has been stolen and looted by some unknown Kuki resident of Leimatak. The total approximate cost of the total items is around Rs 7, 28,500 (Seven lakhs twenty-eight thousand and five hundred).


Hence, I sincerely request you to kindly take up necessary action to help me recover the vehicle.
