

I would like to state the following few lines for your kind attention and necessary action.

That, on 7/05/2023, I have been rescued from the quarter no. type II/B-08, Leimatak which is allotted to me due to the current communal clash and I left all my belonging like valuable household items, kitchen items, apparels, commercial Items gold ornaments, Rs. 30,000/- as cash amount inside my quarter at Leimatak with locked and key. I am a contract NHPC employee posted at Power House Station NHPC Ltd, Leimatak for the last 10 years.

However, on 19/09/2023 at around 7:10 PM my friend of Leimatak informed me that my quarter lock had been broken and looted/stolen all my household items and other valuable Items by some unknown persons suspected to be Kuki miscreants/ militants. The approximate value of the looted/stolen items is around Rs. 10,15,000/- (Ten Lakhs & Fifteen Thousand). I can not report timely as I was very busy.


Hence, I sincerely request you to kindly take up necessary action.
