for you kind consideration and necessary action.

That on 3rd May 2023 at about 6:08 pm, some unknown persons numbering about
200 belonging to KUKI community started attacking the undersigned along with family members.
Thereafter, the KUKI people started destroyed and burning the house of the undersigned resulting in
all the properties of the undersigned were razed to the ground and all the belongings and jewelleryes
were also burned/destroyed/stolen before burning/damage.

In the said incident _____ was badly injured due to pelting of
stones/hacking with knife/shot form firearms toward us by the miscreants.

A separate sheet showing the particulars of all the losses incurred by me is attached along
with the present application.

In the above facts and circumstances, it is therefore respectfully requested that your goodself
my cause the arrest of the miscreants who belongs to the KUKI community involved in the
burning/dismantling/ damaging my properties and injuring _____ and take
and FIR against them as soon as possible for the interest of justice.
