

I would like to state the following few lines for your kind attention and necessary action.

I am a contract employee at NHPC Leimatak and posted at Leimatak for the past 10 years. My allotted quarter no is type II/H-21. I left my quarter on 07/05/2023 due to the current communal clash leaving behind all my valuable household items, kitchen items, apparels, gold ornaments etc as well as one Alto car white in colour bearing registration no. MN06LA6833 Chassis No. MA3EAA61S191177 Engine NO. F8D4685152.

However, on 07/05/2023 at around 5:30 PM one of my friend from Leimatak informed me that my quarter has been broke in and all my household items have been looted/stolen including my Alto car by some unknown persons suspected to be Kuki miscreants/ militants. The approximate value of the looted/stolen items is around Rs. 10,50000/- (Ten Lakhs & Fifty Thousand). I could not report in time due to the current law and order situation as well as I was ill for the past few weeks.

Hence, I sincerely request you to kindly take up necessary action.
