I am a contract employee at NHPC Leimatak and posted at Leimatak. My allotted quarter no is type II/H-25. Due to the current communal clash, I left my quarter on 07/05/2023 leaving behind all my valuable household items, kitchen items, apparels, gold as well as some cash total value at around Rs 9,30000 (Nine Lakhs and Thirty Thousand).

However, on 25/09/2023 at around 3:30 PM one of my friends from Leimatak informed me that my quarter has been broke in and all my household items which I have left have been looted/stolen by some unknown persons suspected to be Kuki miscreants/ militants. The approximate value of the looted/stolen items is around Rs 9,30000 (Nine Lakhs and Thirty Thousand). I could not report in time due to the current law and order situation and my hand was broken for the past few months.

Hence, I sincerely request you to kindly take up necessary action.
