

Sir,

I am a contract employee at NHPC Leimatak and posted at Leimatak. My allotted quarter no is type II/H-25. Due to the current communal clash, I left my quarter on 07/05/2023 leaving behind all my valuable household items, kitchen items, apparels, gold as well as some cash total value at around Rs 9,30000 ( Nine Lakhs and Thirty Thousand).

However, on 25/09/2023 at around 3:30 PM one of my friends from Leimatak informed me that my quarter has been broke in and all my household items which I have left have been looted/stolen by some unknown persons suspected to be Kuki miscreants/ militants. The approximate value of the looted/stolen items is around Rs 9,30000 (Nine Lakhs and Thirty Thousand). I could not report in time due to the current law and order situation and my hand was broken for the past few months.

Hence, I sincerely request you to kindly take up necessary action.
