Sir,

On dated 13/10/2023 at about 0300 hrs, a reliable input received from DC (G) FGT BSF Imphal that amid the ethnic clash, some armed miscreants have been trying to transport sophisticated arms and ammunition from general area of Charoi Khullen Village under Churacandpur District. It was also learnt that Arms& Ammunition have been kept at isolated place near a stream near Charoi Kullen.

Acting on the input of BSF, a combined team led by Satyaam Takhellambam (Addl. SP-L/O BPR), Amarjit Lamabam (Addl SP-Ops BPR) along with FGT Imphal (SOs- 02, ORs -03), troops of 10 Bn BSF (Officer- 01, SOs -04, ORs -25, total 30 personnel) led by Md Rashid Reza, DC(G) FGT, Imphal and 2 teams of Loktak PS led by Inspt. Th Kirankumar Singh (OC-LTK/PS) and one team of CDO BPR(Q-51) led by Hav. Samuel Kamei, carried out a massive joint operation in the general area of Charoi Khullen from 130600 hrs till 130815 hrs.
