I would like to report that on 03/05/2023 at around 8:00 PM my vehicle Tata Yodha 1700 Pickup BSVI bearing Regd No. MN01AA 5446, chassis no: MAT464662NSB02615, Engine No: VARICOR12BXX J03219 which was kept parked inside the residential compound of Khaitinliam Vaiphei located at Kangvai Village, CCPur was burnt by an angry mob armed with deadly weapons. The vehicle is registered under my name and is covered by insurance till 29/04/2024 by Tata AIG General Insurance Company Limited. The estimate value of the burnt vehicle is Rs 14,00,000/- (approx).

In this regard I would like to request you to kindly look into the matter and take necessary legal action against the persons involved at the earliest. The late in report is due to the prevailing law and order situation in the state.
