Respected Sir,

I am to state that I along with my family members are resident of Kangvai Village, Kangvai Sub-division with house no. 39. On the fateful night of 4<sup>th</sup> May 2023 at around 3:30 pm, my house was under attacked with stones, sticks, iron rod and with sophisticated weapons like AK Rifles, SLR etc by thousands of miscreants belonging to Arambai Tenggol group, World Meetei Council, Meetei Leepun numbering 1000 in all with an intention to kill all my family members. They broke open my gate and started damaging, looting and thus burning down all my properties and house. The list of my stolen properties are shown in Annexure-I.

Such a gruesome attacked and barbaric act on innocent civilians with an intention to kill, looting and torching down all my properties worth ₹24.59 lakh approximately without any reason is highly condemnable and totally uncalled for and tantamount to criminal act which calls for booking of the culprits under appropriate section of the Indian Penal Code. I, therefore, pray that the culprits may be apprehended and befitting punishment may be awarded as per law of the land at the earliest.
