Sir,

With due regards and humble request, I have the honour to state that on 04/05/2023 at about 12:30 pm, some unknown persons numbering about 400/500 belonging to Kuki Community started attacking us. Thereafter, the Kuki people started destroying and burning my shop namely, Jupiter Enterprises having GST, Tin No. 14AEKPH2959F1ZJ located at New Bazar, Axis Bank Ground Floor, Churachandpur resulting in all the properties were razed to the ground and all the belongings were also burned in the incident. The approximate value of the loss is about Rs. 80,00,000/- (Eighty Lakhs only). Now I am settled at the house of my brother namely, Haorokcham Ibomcha Singh (49) C/o H. Iboyaima Singh, residing at Awangkhumou Mamang Leikai, Imphal West, Manipur.

In the above facts and circumstances, it is therefore respectfully requested that your goodself may cause the arrest of the miscreants who belongs to the Kuki Community involved in the incident and take up an F.I.R. against them as soon as possible for the interest of the justice.
