Manupur -I have the honour to report that on 4/5/2023 at about 11:30 am following a mass rally of Tribal Solidarity day at ATSUM(All Tribal Student's Union of Manipur) on 3/5/2023, some personals of Kuki Tribe(suspected to be personnel of certain Kuki armed miscreants outfit) came to our locality at Khumujamba Meitei Leikai Churchandpur, in an organised from holding deadly weapons like Gun, Swords, Dao, Stick etc. in a was footing manner including sounds of gun fire in my locality with an attempt to kill the people of the locality belonging to our Meitei community. Seeing the apprehending danger of the situation I and my family somehow escaped from the place for our safety. However the volunteers set fire my Pucca Dwelling house and other appurtenance constructed in the homestead land under Patta No. 177(Pt)(old)/724/1574(New), C.S. Dag No. 1214/1346, of revenue village No. 96- Khupidung, of Churchandpur District, Manipur and as a result my said dwelling house with other apartments and all house hold belongings of movable properties. and valuable documents kept therein turned into ash. In the Violence my Family's properties including my house which is a two storey pucca house, my wife's & daughter in law's gold ornaments and all other household requirements and accessories which sum an amount about Rs. 80,00,000/-(eighty lakhs) had been destroyed. AS such I and my family consisting of 7 (seven) members suffer huge loss and untold suffering being homeless with nothing to survive. I could not report the incidence earlier in the tense law and order situation and now I and my family is taking shelter at the residence of my near relative namely Mr. Yumnam Bor Meetei of Yurembam Makha Leikai and now it is reported when there is little normalcy in the locality but not yet stable. So, your kindness be pleased to take necessary legal action against the culprits as well as for our rehabilitation measures.
