A facebook post is under circulation in social media containing video image of a vehicle carrying metallic material stopped at Silchar, from transporting the same from Churachandpur via Mizoram to a scrap recycling factory in Silchar. The material is alleged to have been sold as scrap out of household goods and building material from houses burnt in Churachandpur in the ongoing violence. Ngasi date 9/06/2023 nungthil gi pung 3 pm aduwaida AAMYA da Churachandpur dagi Meitei gi yum mei thakhiba mayamdudagi leihauba lemhauba potchei mayam adu Mizoram taraga Silchar gi factory amada yonnaba porak e haina tabadagi AAMYA gi thouburel singna gari adu faraga Assam Police ta sinnakhre. Garigi driver gi ming S Ahmed Kwri Bengali Muslim ni driver adoh, mahaakta 21,000 /- piraga Silchar da potchei sing asi ywhallucho haina tharakpani hairak e. Potchei sing asi chaurakna 11,000 kg lumbapotchei sing oidoini, asida fridge, tv, gas cylinder, cycle na chingba mayam yaure. Kuki na Meitei bu huranbani haina yam thokkhibani hujk t asengba huranba adu kanano haibado meeyamna khangbirammani. I want to appeal to the Assam Police plz investigate deeply in this matter and the illegal activities that are done by the Kuki insurgents in our Silchar, Cachar must be stopped"

#### LOOTING AND DESTRUCTION OF EVIDENCE BY KUKI TERRORIST

"As enquiry commission starts to take its own course in Manipur, we anticipated that the Kuki terrorist who vandalised and destroyed Meitei houses and properties would surely try their level best to destroy EVIDENCE of their terror activities and vandalism in Churachandpur and Moreh in Manipur. AAMYA also suspected the involvement of Mizoram CM and Mizo police in concealing facts and promoting propaganda to patronise and shelter the Kuki terrorist, the true perpetrators of Manipur violence. So AMMYA volunteers were keepinfg close vigil along the Assam Mizoram Border as the reports of entry illegal Kuki immigrants from Myanmar into Assam via Mizoram are constantly being received. We received reports that illegal transport of looted materials from vandalising meitei houses and properties in Churtachandpur are going on with full patronage from Mizoram to serve 2(two) purpose. 1) To raise funds for fresh terror activities in Manipur and other Meitei inhabited areas outside Manipur. 2) To destroy of their terror and vandalism as the enquiry commission is underway. So far AMMYA could not detect them. But yesterday at around 2 pm, getting information from a reliable source, we intercepted a Truck bearing registration No. AS01 LC 9235 bound for Silchar coming from Churachandpur via Mizoram. We found vandalised house materials like table, parts of doors, gas stoves and cylinders and many other broken house materails in the Truck and the driver of the truck revealed everything. We filed an FIR at the spot of interception, that is, near the Assam University Gate, Dorgakona Silchar. Reluctant of the police IN CHARGE to register the case is very unfortunate. Chief Advisor AAMYA".

Hence a suo moto case under FIR NO.427(06)2023 CCP-PS u/s 379/34 IPC has been registered for investigation
