Sir,

With due regard and humble request, I have the honour to state that on 03/05/2023 at about 4:50 pm, some unknown persons numbering about 400/500 belonging to Kuki community started attacking us. Thereafter, the Kuki people started destroying and burning my rented house at Zou Veng Meitei leikai resulting in all the properties were razed to the ground and all the belongings were also burned in the incident. The approximate value of the loss is about Rs. 20,00,000/- (Twenty Lakhs). Now, I am settled at the house of my brother namely Haorkcham Ibomcha Singh (49) S/o H. Iboyaima Singh located at Awangkhunou Mamang Leikai, Imphal West.

In the above facts and circumstances, it is therefore respectfully requested that your good self may cause the arrest of the miscreants who belongs to the Kuki community involved in the incident and take up an FIR against them as soon as possible for the interest of the justice.
