

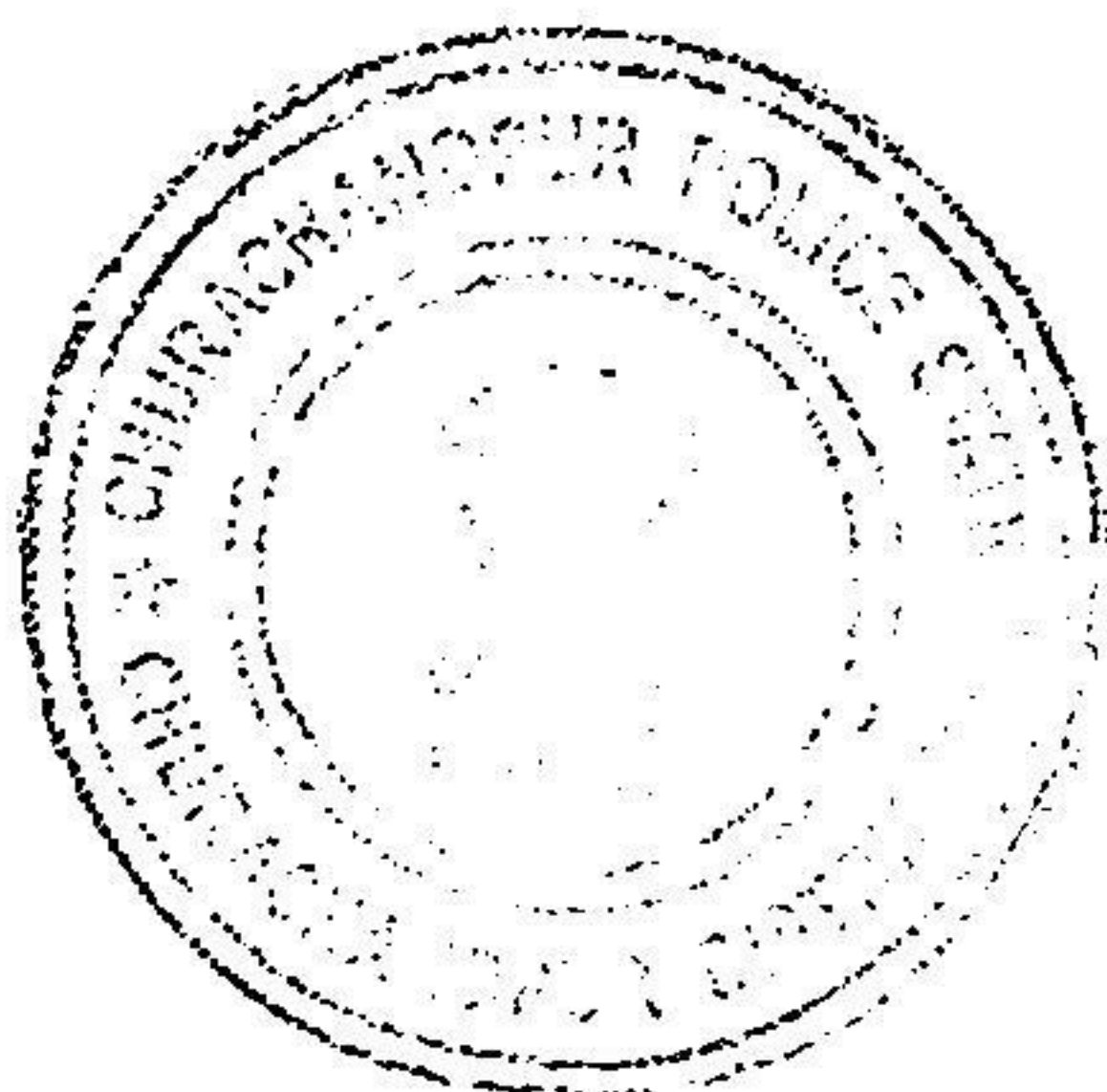
Sir,
