- 3) Almirah (+1)
- 4) Dining table and chairs.
- 5) Beds (4)
- 6) Clothes
- 7) Syntan and all Bathroom items.
- 8) Trunk boxes.
- 9) Scooter and bicycle.
- 10) Tables.
- 11) Mattresses, blankets, pillows.
- 12) Tin (7 pcs).
- 13) Wood planks.
- 14) Gas stoves, cylinders, and all kitchen wares.

That, the estimated value of all the property destroyed and burnt is to be worth approximately Rs. 50,00,000 only.

I kindly request you to kindly take responsibility and legal actions.
