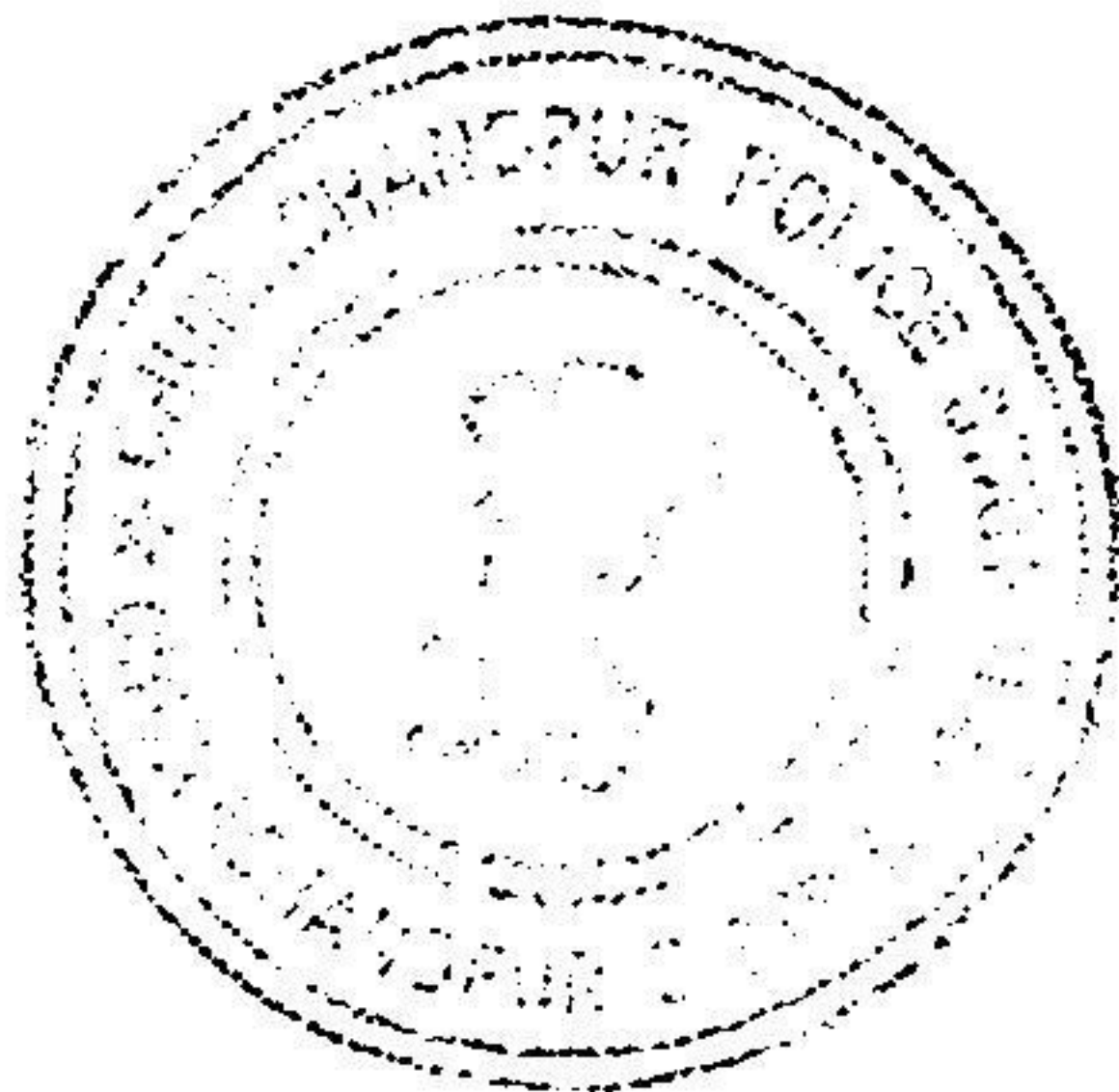
Sir,
