

I would like to state the following few lines for your kind attention and necessary action.

That, on 01/05/2023, I had left my quarter no. Type- II/C-7, leimatak which is allotted to me and I left all my belonging like valuable household items, kitchen items, apparels, tools and Machines for house electric fitting works, electronic goods, LED TV sets, gold ornaments & some cash amount aprox. Rs. 30,000/- inside my quarter at Leimatak with locked and key. I am a contract NIIPC employee posted at Power House Station NIIPC Ltd, Leimatak for the last 12 years.

However, on 08/10/2023 at around 5:15 PM I was being informed that my quarter lock had been broken and looted, stolen all my household items and other valuable Items by some unknown persons suspected to be Kuki residence of Leimatak. The approximate value of the looted, stolen items is around Rs. 7,20,000/-(Seven Lakhs & Twenty Thousand). I can not report timely as I was very busy.

Hence, I sincerely request you to kindly take up necessary action.
