Due to such attacked carried out against me and my families, being in vulnerable state. We had fled from our village i.e Torbung Veng, near Kangvai, P.O, P.S. & District - Churachandpur, on account of fearing to lose our life.

As such, me and my families members have been taking shelter at B. Vengom, KBC relief camp.

On inquiry, my resident was ransacked and burnt down to ground. Properties were looted and taken away.

Therefore, I seek your kind intervention to register an FIR against the culprit and instigator who abate to carried out such heinous attack against me and my families for the end of justice.
